Executive Building Elevator Upgrade project consists of: replacing in kind two (2) five-stop hydraulic passenger elevators; bringing the machine room up to current code requirements; installation of a one-hour fire rated suspended ceiling system in the machine room along with relocation of fire sprinkler heads, smoke detector, and other ceiling mounting elements; installation of a mini-split unit in the machine room along with associated electrical and piping connections; providing lighting upgrades to the elevator lobby spaces immediately adjacent to the elevator doors; interior patching and repair work for wall and ceiling installations.
